

## FIDLER-GREYWILLOW WILDLAND PROVINCIAL PARK

## FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the Province of Alberta, Canada and being more particularly described as follows:

Commencing at the intersection of the right bank of an unnamed creek with the north west shoreline of Lake Athabasca in the north east quarter of section seven (7) in unsurveyed township one hundred eighteen (118), range one (1), west of the fourth (4) meridian;

Thence generally south westerly along the said shoreline to its intersection with the left bank of an unnamed creek in the south west quarter of section four (4) in unsurveyed township one hundred seventeen (117), range three (3), west of the fourth (4) meridian;

Thence northeasterly on a bearing of fifty (50) degrees, zero (0) minutes to the intersection with the right bank of the first described unnamed creek in the north half of section twelve (12) in unsurveyed township one hundred eighteen (118), range two (2), west of the fourth (4) meridian;

Thence easterly along the said right bank of the said unnamed creek to the point of commencement, as shown upon a map or plan of record in the Department of Environmental Protection at Edmonton as No. P0372 General, containing four thousand five hundred thirty-four and fifty thousandth (4,534.050) hectares (11,203.48 acres), more or less.

## SAVING AND EXCEPTING:

Four hundred five thousandths (0.405) of a hectare (1.00 acre), more or less, required for Miscellaneous Permit No. 940065.

## **SECONDLY**:

All those parcels or tracts of land, situate, lying and being in the Province of Alberta, Canada and being composed of:

- (A) All those portions of section seven (7) in unsurveyed township one hundred fifteen (115), range three (3), west of the fourth (4) meridian; Section three (3), the south half of section four (4), section eleven (11) and the west half of section twelve (12) in unsurveyed township one hundred fifteen (115), range four (4), west of the fourth (4) meridian; the north east quarter of section nineteen (19), the north half of section twenty (20), section twenty-eight (28), twenty-nine (29), thirty-two (32), thirty-three (33) and the west half of section thirty-four (34) in unsurveyed township one hundred fourteen (114), range four (4), west of the fourth (4) meridian, comprising Burntwood Island and all other islands in Lake Athabasca lying within the described lands, as shown upon the said map or plan of record in the said Department of Environmental Protection as No. P0372 General, containing eight hundred seventy-one and four hundred thousandths (871.400) hectares (2,153.20 acres), more or less.
- (B) All those portions of the north east quarter of section thirty-five (35) and the north half of section thirty-six (36) in unsurveyed township one hundred twelve (112), range five (5), west of the fourth (4) meridian; the south west quarter of section six (6) in unsurveyed township one hundred thirteen (113), range four (4), west of the fourth (4) meridian; Sections one (1), two (2), three (3), and four (4), the north west quarter of section seven (7), the south east quarter of section nine (9), sections ten (10), eleven (11) and twelve (12), the south half of section thirteen (13) and sections fourteen (14), fifteen (15), twenty-three (23) and twenty-four (24) in unsurveyed township one hundred thirteen (113), range five (5), west of the fourth (4) meridian, comprising Bustard Island, Lucas Islands and all other islands in Lake Athabasca lying within the described lands, as shown upon the said map or plan No. P0372 General, containing one thousand one hundred fifteen and five hundred eighty thousandths (1,115.580) hectares (2,756.56 acres), more or less.

The lands herein described contain six thousand five hundred twenty and six hundred twenty-five thousandths (6,520.625) hectares (16,112.46 acres), more or less.
