

LAKELAND PROVINCIAL PARK

FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the sixty-fifth (65) township, in the eleventh (11) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections thirty-three (33) and thirty-four (34), the north west quarters of sections twenty-seven (27) and thirty-five (35) and the north east quarter of section twenty-eight (28) of the said township, containing seven hundred eighteen and seven hundred forty-seven thousandths (718.747) hectares (1,776.00 acres), more or less.

SECONDLY:

All those parcels or tracts of land, situate, lying and being in the sixty-sixth (66) township, in the tenth (10) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections thirty-one (31) and thirty-two (32), the north west quarters of sections nineteen (19) and twenty-eight (28), the north half of section twenty-nine (29), the north half and south west quarter of section thirty (30), and the west half of section thirty-three (33) of the said township, containing one thousand one hundred eight and four hundred seventy-three thousandths (1,108.473) hectares (2,739.00 acres), more or less.

THIRDLY:

All those parcels or tracts of land, situate, lying and being in the sixty-sixth (66) township, in the eleventh (11) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections three (3), four (4), nine (9), ten (10), fourteen (14), fifteen (15), twenty-two (22), twenty-three (23), twenty-four (24), twenty-five (25), twenty-six (26), twenty-seven (27), thirty-three (33), thirty-four (34), thirty-five (35) and thirty-six (36), the west half of section two (2), the north east quarter of section five (5), the east half of section eight (8), the north halves and the south west quarters of sections eleven (11) and thirteen (13) and the north halves of sections thirty-one (31) and thirty-two (32) of the said township, containing five thousand one hundred seventy and nine hundred seventeen thousandths (5,170.917) hectares (12,777.16 acres), more or less.

FOURTHLY:

All that parcel or tract of land, situate, lying and being in the sixty-sixth (66) township, in the twelfth (12) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

The north east quarter of section thirty-six (36) of the said township, containing sixty-five and one hundred fifty-seven thousandths (65.157) hectares (161.00 acres), more or less.

FIFTHLY:

All those parcels or tracts of land, situate, lying and being in the sixty-seventh (67) township, in the tenth (10) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections four (4), five (5), six (6), seven (7), eight (8), nine (9), eighteen (18), nineteen (19) and thirty (30), the west halves of sections seventeen (17), twenty (20) and twenty-nine (29) and the south half of section thirty-one (31) of the said township, containing two thousand eight hundred eighty-nine and seven hundred twenty-five thousandths (2,889.725) hectares (7,140.41 acres), more or less.

SIXTHLY:

All those parcels or tracts of land, situate, lying and being in the sixty-seventh (67) township, in the eleventh (11) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections one (1), two (2), three (3), four (4), five (5), six (6), ten (10), eleven (11), twelve (12), thirteen (13), fourteen (14), fifteen (15), twenty-two (22), twenty-three (23), twenty-four (24), twenty-five (25), twenty-six (26) and twenty-seven (27) of the said township, containing four thousand seven hundred forty-seven and four hundred ninety-nine thousandths (4,747.499) hectares (11,730.91 acres), more or less.

The lands herein described contain fourteen thousand seven hundred and five hundred eighteen thousandths (14,700.518) hectares (36,324.48 acres), more or less.
