## LAKELAND PROVINCIAL RECREATION AREA

### FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the sixty-fourth (64) township, in the tenth (10) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Section thirty-two (32) and the north half of section thirty-one (31) of the said township, containing three hundred eighty-eight and five hundred twelve thousandths (388.512) hectares (960.00 acres), more or less.

### SECONDLY:

All those parcels or tracts of land, situate, lying and being in the sixty-fourth (64) township, in the eleventh (11) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

The north east quarter of section thirty-five (35) and the north half of section thirty-six (36) of the said township, containing one hundred ninety-four and two hundred fifty-six thousandths (194.256) hectares (480.00 acres), more or less.

### SAVING AND EXCEPTING:

Two and five hundred forty-two thousandths (2.542) hectares (6.28 acres), more or less, out of the said township, required for a surveyed roadway as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 3174 P.X.

### THIRDLY:

All those parcels or tracts of land, situate, lying and being in the sixty-fifth (65) township, in the ninth (9) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections seven (7), eight (8), seventeen (17), eighteen (18), nineteen (19), twenty (20), twenty-nine (29), thirty (30), thirty-one (31), thirty-two (32), thirty-three (33), thirty-four (34) and thirty-five (35) of the said township, containing three thousand four hundred nine and five hundred thirty-three thousandths (3,409.533) hectares (8,424.84 acres), more or less.

### SAVING AND EXCEPTING:

- 1) All that portion of the north west quarter of section eighteen (18) of the said township, not covered by any of the waters of Pinehurst Lake, containing seventeen and one hundred nineteen thousandths (17.119) hectares (42.30 acres), more or less.
- 2) All that portion of the south east quarter of section nineteen (19) of the said township, not covered by any of the waters of the said Pinehurst Lake, containing fifty-three and seven hundred forty-four thousandths (53.744) hectares (132.80 acres), more or less.

### FOURTHLY:

All those parcels or tracts of land, situate, lying and being in the sixty-fifth (65) township, in the tenth (10) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections five (5) to thirty-six (36) inclusive of the said township, containing eight thousand three hundred twenty-five and four hundred forty thousandths (8,325.440) hectares (20,571.88 acres), ore or less.

SAVING AND EXCEPTING:

Seven and six hundred eighty-nine thousandths (7.689) hectares (19.00 acres), more or less, out of the said township, required for a surveyed roadway as shown upon a plan of survey of record in the said Land Titles Office as No. 3189 P.X.

FIFTHLY:

All those parcels or tracts of land, situate, lying and being in the sixty-fifth (65) township, in the eleventh (11) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections one (1), twelve (12), thirteen (13), twenty-four (24), twenty-five (25) and thirty-six (36), the east halves of sections two (2) and eleven (11) and the south east quarter of section fourteen (14) of the said township, containing one thousand eight hundred sixty-eight and eight hundred thirty-six thousandths (1,868.836) hectares (4,617.83 acres), more or less.

SAVING AND EXCEPTING:

- 1) Four and five hundred seventy-seven thousandths (4.577) hectares (11.31 acres), more or less, out of the said township, required for a surveyed roadway as shown upon the said Plan No. 3189 P.X.
- 2) One and three hundred fifty-two thousandths (1.352) hectares (3.34 acres), more or less, out of the said township, required for a surveyed roadway as shown upon the said Plan No. 3174 P.X.

SIXTHLY:

All those parcels or tracts of land, situate, lying and being in the sixty-sixth (66) township, in the ninth (9) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections two (2) to eleven (11) inclusive, sections fourteen (14) to twenty-three (23) inclusive and sections twenty-six (26) to thirty-five (35) inclusive of the said township, containing seven thousand seven hundred seventy-one and eight hundred fifty-nine thousandths (7,771.859) hectares (19,204.00 acres), more or less.

SEVENTHLY:

All those parcels or tracts of land, situate, lying and being in the sixty-sixth (66) township, in the tenth (10) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections one (1) to eighteen (18) inclusive, sections twenty (20) to twenty-seven (27) inclusive, sections thirty-four (34), thirty-five (35) and thirty-six (36), the east halves and south west quarters of sections nineteen (19) and twenty-eight (28), the south half of section twenty-nine (29), the south east quarter of section thirty (30) and the east half of section thirty-three (33) of the said township, containing eight thousand two hundred sixty and five hundred twenty-two thousandths (8,260.522) hectares (20,411.47 acres), more or less.

EIGHTHLY:

All those parcels or tracts of land, situate, lying and being in the sixty-sixth (66) township, in the eleventh (11) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections one (1) and twelve (12), the east half of section two (2) and the south east quarters of sections eleven (11) and thirteen (13) of the said township, containing seven hundred eighty-one and eight hundred eighty thousandths (781.880) hectares (1,932.00 acres), more or less.

NINTHLY:

All those parcels or tracts of land, situate, lying and being in what would be if surveyed the sixty-seventh (67) township, the ninth (9) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections four (4), five (5), six (6), seven (7), eight (8), nine (9), seventeen (17), eighteen (18), nineteen (19), twenty (20), twenty-nine (29), thirty (30), thirty-one (31), thirty-two (32) and thirty-three (33), and all those portions of sections sixteen (16), twenty-one (21) and twenty-eight (28) of the said township, not covered by any of the waters of Spencer Lake, containing four thousand four hundred seventy-nine and six hundred seventy-seven thousandths (4,479.677) hectares (11,069.13 acres), more or less.

TENTHLY:

All those parcels or tracts of land, situate, lying and being in the sixty-seventh (67) township, in the tenth (10) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections one (1), two (2), three (3), ten (10) to sixteen (16) inclusive, twenty-one (21) to twenty-eight (28) inclusive, thirty-four (34), thirty-five (35) and thirty-six (36), and the east halves of sections seventeen (17), twenty (20) and twenty-nine (29) of the said township, containing five thousand nine hundred eight and two hundred seventy-two thousandths (5,908.272) hectares (14,599.14 acres), more or less.

ELEVENTHLY:

All those parcels or tracts of land, situate, lying and being in what would be if surveyed the sixty-eighth (68) township, the ninth (9) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections four (4), five (5), six (6), seven (7), eight (8) and nine (9) of the said township, containing one thousand five hundred seventy-seven and six hundred two thousandths (1,577.602) hectares (3,898.20 acres), more or less.

TWELFTHLY:

All those parcels or tracts of land, situate, lying and being in the sixty-eighth (68) township, in the tenth (10) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Sections one (1), two (2), three (3), eleven (11) and twelve (12) and the south half of section ten (10) of the said township, containing one thousand four hundred fifty and three hundred eighty thousandths (1,450.380) hectares (3,583.84 acres), more or less.

The lands herein described contain forty-four thousand three hundred twenty-nine and seven hundred forty-five thousandths (44,329.745) hectares (109,537.30 acres), more or less.
