

HUBERT LAKE WILDLAND PROVINCIAL PARK

FIRSTLY:

All those parcels or tracts of land, situate, lying and being in sixty-fourth (64) township, in the second (2) range, west of fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

Sections seven (7) to eleven (11) inclusive, the west halves of sections twelve (12) and thirteen (13), sections fourteen (14) to twenty-three (23) inclusive, the west halves of sections twenty-four (24) and twenty-five (25), sections twenty-six (26) to thirty-five (35) inclusive, the south west quarter of section thirty-six (36) and all those portions of the north east quarter of the said section twenty-five (25) and the north half and south east quarter of the said section thirty-six (36) of the said township lying generally to the west of the left bank of the Pembina River.

SAVING AND EXCEPTING:

- Four and five hundred seventy-seven thousandths (4.577) hectares (11.31 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 15 E.O.
- 2) Five and one hundred twenty-four thousandths (5.124) hectares (12.66 acres), more or less, required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 822 0086.

SECONDLY:

All those parcels or tracts of land, situate, lying and being in the sixty-fourth (64) township, in the third (3) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The south east quarter of section twelve (12), the north east quarter of section thirteen (13), the south half and north east quarter of section thirty-six (36) and all those portions of the north half and south west quarter of the said section twelve (12), the south half and north west quarter of the said section thirteen (13), section twenty-four (24), the north half and south east quarter of section twenty-five (25), the north east quarter of section twenty-six (26), the east half of section thirty-five (35) and the north west quarter of section thirty-six (36) of the said township lying generally to the east of the right bank of the Athabasca River.

THIRDLY:

All those parcels or tracts of land, situate, lying and being in the sixty-fifth (65) township, in the second (2) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The south half and north west quarter of section two (2), sections three (3) to six (6) inclusive and all those portions of the south half and north west quarter of section one (1) and the north east quarter of the said section two (2) of the said township lying generally to the west of the left bank of the said Pembina River.

FOURTHLY:

All those parcels or tracts of land, situate, lying and being in the sixty-fifth (65) township, in the third (3) range, west of the fifth (5) meridian, in the Province of Alberta, Canada, and being composed of:

The east half of section one (1) and all that portion of the west half of the said section one (1) of the said township lying generally to the east of the right bank of the said Athabasca River.

The lands herein described contain nine thousand six hundred sixty-five and four hundred sixty thousandths (9,665.460) hectares (23,883.61 acres), more or less.
