

RIBSTONE CREEK HERITAGE RANGELAND NATURAL AREA

All those parcels or tracts of land, situate, lying and being in the Province of Alberta, and being composed of:

FIRSTLY: In Township 42, Range 3, West of the 4th Meridian:

The north east quarter of section 28, section 29, the south half of section 30, the east half of section 31, section 32, the south half of section 33, section 34, the north half and south west quarter of section 35 and the north west quarter of section 36 as shown outlined upon a map or plan of record in the Department of Environment at Edmonton as No. P0393 GEN.

SECONDLY: In Township 43, Range 3, West of the 4th Meridian:

The south half of section 2, section 3, the south half and north west quarter of section 4, sections 5, 6 and 7, the north half of section 9, the north half and south east quarter of section 10, section 11, the north half of section 12, the south half of section 13, sections 14 to 17 inclusive, the south west and north east quarter of section 18, the east half of section 19, section 20, the south halves and north west quarters of sections 21 and 22, sections 27, 28 and 29, the north half and south east quarter of section 30 and sections 31, 32 and 33, as shown outlined upon the said map or plan No. P0393 GEN.

SAVING AND EXCEPTING:

- 1) Four hundred five thousandths (0.405) of a hectare (1.00 acre), more or less, out of the south east quarter of the said section 2 as described in Certificate of Title No. 101Y70.
- 2) Thirty-one and two hundred sixty three thousandths (31.263) hectares (77.25 acres), more or less, out of sections 22, 28, 29, 30, 31 and 32 required for a railroad right-of-way, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. RW 37.
- 3) Twenty-four and nine hundred seventy-four thousandths (24.974) hectares (61.71 acres), more or less, out of sections 27, 28, 29, 31 and 32 required for a surveyed roadway, as shown upon a plan of survey of record in the said Land Titles Office as No. 1616 R.S.
- 4) Thirty-nine and nineteen thousandths (39.019) hectares (96.41 acres), more or less, out of sections 32 and 33 required for a golf course, as shown upon a plan of record in the said Department of Environment as No. 5296 GEN.

THIRDLY: In Township 44, Range 3, West of the 4th Meridian

The west half of section 3, section 4, the south west quarter of section 5, the south east quarter of section 6 and all that portion of the north west quarter of the said section 5 being more particularly described as follows: commencing at the south west corner of the said quarter section; thence northerly along the west boundary thereof a distance of six hundred (600) feet, thence easterly and parallel to the south boundary of the said quarter section a distance of fifteen hundred (1500) feet, thence southerly and parallel to the said west boundary to a point on the said south boundary, thence westerly along the said boundary to the point of commencement, as shown outlined upon the said map or plan No. P0393 GEN.

SAVING AND EXCEPTING:

Sixteen and one hundred thousandths (16.100) hectares (39.78 acres), more or less, out of section 4 required for the said golf course as shown upon the said plan No. 5296 GEN.

FOURTHLY: In Township 43, Range 4, West of the 4th Meridian

The north east quarter of section 12, the south east quarter of section 13 and the south half of section 36, as shown outlined upon the said map or plan No. P0393 GEN.

The lands herein described contain eight thousand three hundred twenty-seven and two hundred nineteen thousandths (8,327.219) hectares (20,576.28 acres), more or less.
