

## CROW LAKE PROVINCIAL PARK

## FIRSTLY:

All those parcels or tracts of land, situate, lying and being in the seventy-eighth (78) township, in the fourteenth (14) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Legal subdivisions four (4) and fifteen (15) of section thirty-three (33), all those portions of legal subdivision fourteen (14) of section nineteen (19), the north east quarter and the south half of the north west quarter of section thirty-two (32) and legal subdivision five (5) and the north west quarter of the said section thirty-three (33) covered and not covered by the waters of Crow Lake, all those portions of the west half of section thirty (30), section thirty-one (31) and the south half of the said section thirty-two (32) lying generally to the north and west of the south easterly shoreline of the said Crow Lake, covered and not covered by the waters of the said Crow Lake, covered and not covered by the waters of the said Crow Lake and all those portions of legal subdivisions twelve (12) and thirteen (13) of section twenty-seven (27) and legal subdivisions one (1), two (2) and three (3) of the said section thirty-three (33) lying generally to the south and west of the left bank of an unnamed creek.

## SECONDLY:

All those parcels or tracts of land, situate, lying and being in the seventy-eighth (78) township, in the fifteenth (15) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Legal subdivisions one (1) and eight (8) of section twenty-five (25), legal subdivision nine (9) of section thirty-six (36), all those portions of legal subdivisions nine (9) and sixteen (16) of the said section twenty-five (25) and legal subdivisions one (1) and eight (8) of the said section thirty-six (36) covered and not covered by the waters of the said Crow Lake and all those portions of legal subdivisions seven (7), ten (10) and fifteen (15) of the said section twenty-five (25) and legal subdivisions two (2), seven (7) and ten (10) of the said section thirty-six (36) of the said township lying generally to the east of the easterly limit of a surveyed roadway, as shown upon a plan of survey of record in the Land Titles Office at Edmonton for the North Alberta Land Registration District as No. 237 P.X.

## THIRDLY:

All those parcels or tracts of land, situate, lying and being in the seventy-ninth (79) township, in the fourteenth (14) range, west of the fourth (4) meridian, in the Province of Alberta, Canada, and being composed of:

Legal subdivision three (3) of section three (3), legal subdivision two (2) of section four (4) and all those portions of legal subdivision four (4) of the said section three (3) and legal subdivision one (1) of the said section four (4) of the said township covered and not covered by the waters of the said Crow Lake.

The lands herein described contain seven hundred eighty-six and two hundred seventy thousandths (786.270) hectares (1,942.89 acres), more or less.
