

Castle Provincial Park

Designated Camping Areas (DCAs) 1–5, 7, and Equestrian Camping

Camping is all first-come, first-serve with camping fees now in effect.

DCA 1-3: \$20 per night.

DCA 4-5: \$20 per night.

DCA 7: \$15 per night.

Equestrian Camping: \$20 per night.

- Guests will find a self-registration vault, information kiosk, an outhouse and a garbage bin provided at each Designated Camping Area (DCA).
- Choose a camping spot indicated by the DCA number.
- Each camping accommodation unit must purchase a permit within 30 minutes of arriving.
- To register: complete the self-registration permit information and place cash or cheque, payable to the Government of Alberta, in envelope. Seal envelope and place in the registration vault in the Camping Area you are staying in. Affix your OCCUPIED tag to the campsite post at your site.
- Camping must not exceed 16 consecutive nights. Checkout time is 2 pm
- Marked camping locations vary in size and include a shared steel ring fire pit. Bring your own locally sourced firewood.
- Campsites should be within areas allocated and not near water bodies (at least 30 meters away).
- Clearing of vegetation is not permitted. This includes trees, branches, bushes, rocks and fallen logs.
- Please respect any construction or reclamation closures and use gravel access roads to avoid impacting sensitive vegetation in the area.

- All campfires must be fully contained in the shared designated steel ring fire pits, and must not be left unattended. The last person at the fire pit is responsible to put the fire out: soak, stir and soak again.
- Sewage dump stations are located in the town of Pincher Creek and the Crowsnest Pass.
- OHVs are only permitted on signed and designated OHV trails.
- A Conservation Officer may cancel your camping permit under section 42 of the Parks Act by providing notice to the Permit Holder of the cancellation.
- An Equestrian Campground is located at Syncline South Staging Area.
- Equestrians are asked to ensure all straw, shavings, feed and manure are removed from camping areas, staging areas pens and high lines. Manure bins are available for manure disposal.
- Pets must be on leash, supervised, under control and cleaned up after at all times.
- Please respect quiet hours between 11 pm and 7 am, and keep generator use to a minimum.
- Alberta Parks Staff regularly visit DCAs and Campgrounds throughout the day and evenings.
- The Permit Holder acknowledges that in addition to the requirements of this Permit, they must comply with requirements contained in the Provincial Parks Act, RSA 2000, c P-35, the Provincial Parks (General) Regulation AR 102/85 and all other applicable legislation, as amended or replaced from time to time.
- All undeveloped Designated Camping Areas closed for 2024.
- Developed DCA 1–5 opens May 15.
- Staging Area 6 opens July 2024.
